
This letter is in response to your request made under the *Municipal Freedom of Information and Protection of Privacy Act*, (the Act), received on July 2, 2019. This letter is a secondary decision letter following our initial decision letter dated July 11, 2019. Further to your discussion with the Analyst during the week of August 19, 2019, the City of Ottawa conducted a secondary search and can advise the following:

As of December 31, 2018, 42 employees will receive an OMERS RCA pension at some point in the future. Please note that this number includes Police employees. This is based on the RCA contribution in 2018 and the 2018 salary. However, the City of Ottawa cannot confirm the exact number as it is based on the best 5 years as calculated by OMERS upon retirement and circumstances may change.

The City of Ottawa is waiving any further fee that can be charged to process this request since the cost is less than five dollars.

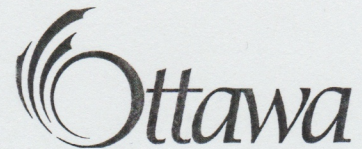
