Thank you for your access to information request received in our office on June 28, 2019, seeking access to the following information:

Please provide documentation on the number of employees in 2018 who were eligible to receive multiple pensions upon retirement. For example, at the City of Calgary most employees received the base plan (the Local Authorities Pension Plan) but 979 employees were also eligible to receive the Supplementary Pension Plan as of 2017. In addition to those two plans, 236 employees were also eligible to receive benefits from a third plan, the Overcap Pension Plan. Some employees in the police and firefighter departments were also eligible to receive multiple pensions. Please provide the data in a summary table (see below for an example).

province of Saskatchewan, employees are not allowed to accrue benefits for the same period of credited service under more than one registered pension plan sponsored by a single employer.
