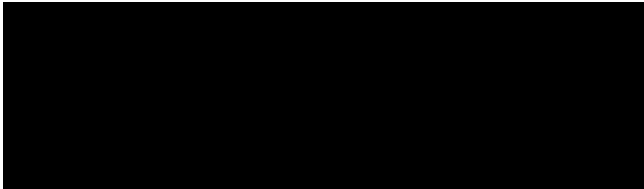

Thank you for your access request under the *Freedom of Information and Protection of Privacy Act (FIPPA)* received by us on June 3, 2020. We acknowledge receipt of your \$5.00 application fee and note that you have asked for access to the following:

Please provide data on the expenses and revenues for all cafeterias and food service facilities (that sell food/beverages to the public) in your hospital(s) for 2017/18 and 2018/19. Please break out the data by health facility, year, and the names of any cafeterias or food service vendors wherever possible. If vendors are privately operated please provide the amount of rent paid to the hospital(s).


On June 9, 2020, I contacted you by telephone for clarification on the time period of the records you are requesting as within the description of the records section of the access request form, you indicated "for 2017/18 and 2018/19". However, under **Time period of the records**, you wrote **From 2017-01-01 To 2020-01-01**. I also wanted to explain that our hospitals function on a Fiscal Year system, for example: April 1, 2017 to March 31, 2018. You agreed to only receive the results for Fiscal Years April 1, 2017 – March 31, 2018 and April 1, 2018 – March 31, 2019. Having received sufficient clarification on the time period of the records you require, the timeline to respond to this request, which we have already begun to process, started June 9, 2020.

We are pleased to grant you full access to the records you requested. Enclosed you will find the following document:
