RE: FREEDOM OF INFORMATION ACCESS REQUEST NUMBER 20-009

Thank you for your letter which was received by our office on May 20, 2020. We have made the following decision in response to your request for information made under the *Freedom of Information and Protection of Privacy Act*. You requested the following:

"Please provide the total amount of rent/lease payments paid to THP from each food vendor separated by individual vendor. Please provide this data for both 2017-2018 and 2018-2019."

I acknowledge receipt of payment in the amount of \$37.50 as payment for the search and processing fee.

I am pleased to enclose the records held by the hospital that respond to your request. You are being provided with full access to the records.

When reviewing the records, please note that all Tim Hortons locations in the Hospitals are owned by Trillium Health Partners Foundation whom is dedicated to raising the critical funds needed to address the highest priority needs of Trillium Health Partners. In support of this mission, Trillium Health Partners does not charge rent for any of these sites.

In addition, you must send an appeal fee to the Commissioner's office. If your request was for your personal information, the appeal fee is \$10.00. The appeal fee for all other requests for information is \$25.00. Please include the fee with your letter of appeal – appeal fees should be in the form of either a cheque or money order, payable to the Minister of Finance.
