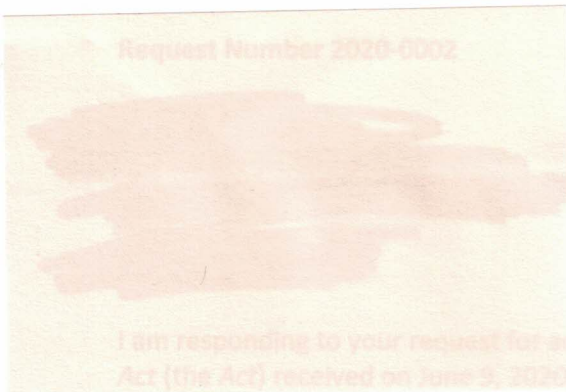


### Access Decision

I am responding to your request for access to records under the Freedom of Information and Protection of Privacy Act (the Act) received on June 9, 2020 as follows:

*Please provide data on the expenses and revenues for all cafeterias and food service facilities (that sell food/beverages to the public) in your hospital(s) for 2017/18 and 2018/19. Please break out the data by health facility, year, and the names of any cafeterias or food service vendors wherever possible. If the vendors are privately operated please provide the amount of rent paid to the hospital(s).*

A decision has been made to grant access to the responsive information.

Section 57 of the Act permits the waiver of fees where it is deemed fair and equitable to do so. As such, the fees for the one (1) page of responsive information is waived.
