Freedom of Information and Protection of Privacy Act

On June 24, 2020, Southern Health-Santé Sud received your application for the following:

Please provide documentation on the number of cancelled or postposed surgeries, health procedures and consultations due to COVID-19. Please be sure to provide any other documentation related to the impact on health care waiting lists due to COVID-19 (and postponed/cancelled health procedures, surgeries, consultations, etc.).

Further to your conversation with Lee Bassett on July 7, 2020, wherein you provided further clarity related to documentation about the impact COVID-19 had on the Region's surgical waiting lists. You confirmed you are seeking documentation pertaining to how the Region will deal with it's surgical backlog for procedures carried out in the operating room. We also discussed that cancelled consultations with surgeons are managed by the clinic the surgeon is associated with.

In accordance with Part 2 of *The Freedom of Information and Protection of Privacy Act*, I am pleased to inform you that your request for access to these records held by the Southern Health-Santé Sud has been granted in part.

Access to portions of these records is refused, as the information in these records falls within the following exceptions to disclosure in *The Freedom of Information and Protection of Privacy Act*:

Contents of response

- 12(1) In a response under section 11, the head of the public body shall inform the applicant
 - (c) if access to the record or part of the record is refused,
 - (i) in the case of a record that does not exist or cannot be located, that the record does not exist or cannot be located.

Advice to a public body

- 23(1) The head of a public body may refuse to disclose information to an applicant if disclosure could reasonably be expected to reveal
 - (a) advice, opinions, proposals, recommendations, analyses or policy options developed by or for the public body or a minister:
 - (b) consultations or deliberations involving officers or employees of the public body or a minister;

Consultations with surgeons are managed by the clinic they are associated with, therefore, Southern Health-Santé Sud does not have a record containing this information. Additionally, we do not have a record related to cancelled consultations with other Health Care Providers due to COVID-19 (i.e. nurses, anaesthetists, etc.).

Specific information and the analysis of the backlog has been redacted to prevent inaccurate inferences to be made by the reader. The record has been shared between officers of the public body to facilitate a decision making process. It includes actions put forward for consideration that have not been carried out.

A copy of these records, as they apply and as they can be reasonably reproduced, in accordance with clause 14(1)(a) of The Freedom of Information and Protection of Privacy Act, are as noted below and enclosed as follows:




SURGICAL WAITLIST PROJECTION FOR SHSS - JUNE 8,2020

Principles of reducing waitlists by site:

- 1. All sites must follow the social distancing requirement for pre and post op patients
- 2. Each surgical site hours of operations need to be fully utilized. These are:
 - BRHC- Monday to Friday 08-1300 one slate on call
 - SAH Tuesday to Friday- 08-1300- one slate
 - BTHC- Monday to Friday- 08-1500-three slates , one emergency slate Saturday and on call
 - Carman Monday to Friday 08 1500- one slate
 - PDGH Monday to Friday 08 1500 –one slate , one slate 08-12:30 on call
- 3. Elective cases can now be part of the slate. These cases need to be prioritized.
- 4. Self isolation is no longer required prior to surgery.
- 5. Patients who screen positive need to have surgery postponed unless there is urgency to complete surgery. These cases would be orange category. COVID testing suggested.







In summary:
