## Surgery Bookings Cancelled due to Patient Death Fraser Health - Calendar Year 2020



This report provides summary counts of bookings for surgery that were cancelled from the FH waitlist during calendar year 2020 due to patient death.

Report date: 2021-01-31

Data source: BC Surgical Patient Registry

Notes:

- These data reflect bookings for surgeries in an operating room. Other areas (such as ambulatory procedure rooms, endoscopy suites, etc) are not reflected here.
- The report covers bookings that were cancelled during the calendar year. There can be a delay between the patient's death and the booking office being notified to cancel the booking. As such, this is not a direct tally of patients who died during the fiscal year.
- In addition, the wait time measurement is from the date the booking form received to date of cancellation of the booking.

  As such, reported wait time will be often greater than the time on the waitlist at the time of death.
- To protect patient confidentiality, tallies of procedure types below 10 counts are not shown directly, but are reflected in the "other" category.
