#### Request

Interior Health (IH) received your request for access to information under the Act. Your request was:

I have two requests. My Requests are as follows:

- 1. Please provide data on the number of patients that died while on a waiting list for a surgical procedure in 2019-20. Please break the data out by procedure and case info date the patient was referred to a specialist, decision date, date for the procedure and date of cancellation. Please also note the government's target time for providing the procedure in question. (Note: many hospitals/health regions were able to identify such cases as they track the reason for cancelled operations)
- 2. Please provide data on the number of patients that died while on a waiting list for either a diagnostic scan or a consultation with a specialist in 2019-20. Please break the data out by procedure and case info date the patient went on the waiting list, date for the meeting with the specialist or date for diagnostic scan (if scheduled), and date of cancellation. Please also note the government's target time for providing the meeting or scan in question. (Note: many hospitals/health regions were able to identify such cases as they track the reason for cancelled operations)

Title IHA Elective Surgical Bookings Cancelled due to Patient Death (FOI 206-IH-2020-2021)

Purpose/Request To provide the number of patients that cancelled surgery due to death while on the

Interior Health wait list for elective surgery by procedure type.

# Findings & Analysis

In Fiscal Year 2019/20, there were 149 booking records cancelled and removed from the Interior Health Authority's (IHA) waitlist due to patient death, representing 2.1% of all cancelled bookings in IHA (7,098 total cancelled bookings). There were over 75 various types of procedures cancelled due to patient death, Cataracts topped the list with 53 (36%) bookings cancelled due to patient death, followed by Arthroplasty Hip Replacements with 14 (9%) cancelled bookings.

The wait time for surgery starts the day the booking form is received at an Interior Health hospital Booking Office to the procedure date (or removal from the waitlist), minus unavailable time reported on the booking record. Of the 149 bookings that were cancelled due to patient death, 11% (17 bookings) had been waiting over the 26-week target wait time for surgery at the date of patient death. Due to low patient volumes, specific case information and target times have been excluded.

The reason for patient death is not documented in Interior Health and is unknown. Consequently, this report cannot be used to determine a correlation between the wait time for surgery and patient death.

## **Data Notes & Limitations**

- Data is based on primary procedure only.
- Data includes elective OR procedures only, both daycare and inpatient cases.
- The data excludes non-OR procedures (z. procedures).
- Data includes only booking records with a cancellation date within Fiscal Year 2019/20 (April 1, 2019 to March 31, 2020)
- Wait times are calculated from the booking form received date to the patient expiry date (Patient date of death), excluding patient unavailable dates. Unavailable time is documented dates that the patient is unavailable for surgery due to personal reasons (i.e. out-of-country, not ready, etc.), or for medical reasons.
- Procedure Group = Surgical Patient Registry (SPR) Procedure Group
- Note: Due to patient confidentially concerns all surgical volumes <10 cases are supressed.</li>

Purpose/Request To provide the number of cancelled Medical Imaging bookings due to death while on the

Interior Health wait list.

## Findings & Analysis

In Fiscal Year 2019/20, there were 618 Medical Imaging bookings cancelled and removed from the Interior Health Authority's (IHA) waitlist due to patient death. The top three Medical Imaging procedures cancelled due to patient death were CTs (249 bookings), Ultrasound (108 bookings), and Echo (96 bookings). These top three Medical Imaging procedures account for over 70% of the total cancelled bookings due to patient death.

The wait time for a Medical Imaging procedure starts the day the booking form is received at an Interior Health hospital to the procedure date (or removal from the waitlist). Of the 618 bookings that were cancelled due to patient death, 42% (262 bookings) had been waiting over the priority wait time target for the Medical Imaging procedure as of the cancelled date. 39% of cancelled Medical Imaging bookings were assigned a Priority level 5 (scheduled exam) and do not have an associated wait time target.

The reason for patient death is not documented in Interior Health and is unknown. Consequently, this report cannot be used to determine a correlation between the wait time for the Medical Imaging appointment and patient death.
