**Request For:** "Please provide data on the number of patients that died while on a waiting list for

surgery or a procedure in fiscal year 2020-21. Please break the data out by procedure and case info -date the patient was referred to a specialist, decision date, date for the procedure and date of cancellation. Please also note the government's target time for providing the procedure in question. (Note: many hospitals/health regions were able to

identify such cases as they track the reason for canceled operations)"

I am writing in response to your request for access to information described above, pursuant to the *Freedom of Information and Protection of Privacy Act* ("the Act"), which was received by Health PEI on June 8, 2021. We are pleased to provide you with access to the available information in the table below.

Please note that the requested information is only available for the specific procedures on which Health PEI reports wait times to the Canadian Institute for Health Information ("CIHI"). In response to your request for case information, we are pleased to provide you with average length of time on wait list prior to cancelation of procedure. As the number of patients included in the counts for each procedure is very low, release of the specific dates related to individual patients could have impacts to personal privacy.

## Notes

- 1. \* Wait list is defined, for the purposes of reporting to CIHI, as the period of time between the patient accepting the first available appointment for the procedure and the booked date for the procedure.
- 2. \*\* The information provided in the table above includes four (4) Surgeon Requested Dates, two (2) First Scheduled Dates, and one (1) Patient Requested Date.
- 3. The date of referral to a specialist is not collected by Health PEI.
- 4. \*\* The data provided is an average length of time on the waitlist prior to the cancellation of the procedure for six (6) of the seven (7) patients as the dates were not available for the 7<sup>th</sup> patient.
