

We are pleased to provide access to responsive records in our custody and control regarding the number of patients that died while on a waiting list for:

- (a) Either a diagnostic scan or a consultation with a specialist between April 1, 2021 and March 31, 2022; and
- (b) Surgery or a procedure between April 1, 2021 and March 31, 2022.

In reviewing this information as it applies to wait times for a surgery or a procedure, we wish to caution you with respect to the quality of the data available. The quality of the data is subject to many constraints, including the following:

- Certain adjustments to the reported wait times may not be made consistently or at all. For example, where the length of time a patient waits for a surgery or a procedure increases due to a patient initiated delay, that period of delay should be excluded from the reported wait time. However, this may not be done consistently in all cases;
- Wait time reporting for surgeries and procedures are completed by surgeons' clinical offices and the reporting process can vary from office to office; and
- We may only become aware of a patient having died while on a waitlist when we call to book the actual appointment.

With respect to wait times for specialist consultations, we caution that this is currently a manual process, there are no standardized reporting practices applicable to this data point and it may, therefore, be prone to underreporting.

You may request that this decision be reviewed by the Information and Privacy Commissioner/Ontario/IPC. Please note you have 30 days from receipt of this letter to request this review. The Commissioner can be reached at:

Should you decide to appeal this decision, please provide the Commissioner's office with:

- A copy of this decision letter

- The reason for your appeal.



Appeals to the Commissioner must be accompanied by the appropriate fee. If your access request is for you personally, the appeal fee is \$10.00. The appeal fee for all other access requests is \$25.00. Please include the fee with your letter of appeal. Appeal fees should be in the form of a cheque or money order, payable to the Minister of Finance.
