

Re: Halton Healthcare FOI Request #2-2023 – Decision Letter

We are writing in response to your two access requests under the *Freedom of Information and Protection of Privacy Act,* which we received on May 2, 2023 together with the \$10 application fee.

Your requests were as follows:

FOI - DIAGNOSTIC / CONSULTATION WITH SPECIALIST:

Please provide data on the number of patients that died while on a waiting list for either a diagnostic scan or a consultation with a specialist in fiscal year 2022-23. Please break the data out by procedure and case info – date the patient went on the waiting list, date for the meeting with a specialist or date for diagnostic scan (if scheduled), and date of cancellation. Please also note the government's target time for providing the consultation or scan in question. (Note: many hospitals/health regions were able to identify such cases as they track the reason for cancelled operations.)

Time period: April 1, 2022 to March 31, 2023

and

FOI - SURGICAL CASES:

Please provide data on the number of patients that died while on a waiting list for surgery or a procedure in fiscal year 2022-23. Please break the data out by surgery/procedure and case information – date the patient was referred to a specialist, decision date, date for the procedure, and date of cancellation. Please also note the government's target time for providing the procedure in question. Note: Many hospitals/health regions were able to identify such cases as they track the reason for cancelled operations.)

Time period: April 1, 2022 to March 31, 2023

We are providing **access** to responsive records in our custody and control regarding the number of patients that died while on a waiting list for:

- (a) Either a diagnostic scan or a consultation with a specialist between April 1, 2022 and March 31, 2023; and
- (b) Surgery or a procedure between April 1, 2022 and March 31, 2023.

Attached to this email are the records as two PDF documents.

In reviewing this information as it applies to wait times for a surgery or a procedure, we wish to caution you with respect to the quality of the data available. The quality of the data is subject to many constraints, including the following:

- Certain adjustments to the reported wait times may not be made consistently or at all.
 For example, where the length of time a patient waits for a surgery or a procedure increases due to a patient initiated delay, that period of delay should be excluded from the reported wait time. However, this may not be done consistently in all cases;
- Wait time reporting for surgeries and procedures are completed by surgeons' clinical offices and the reporting process can vary from office to office; and
- We may only become aware of a patient having died while on a waitlist when we call to book the actual appointment.

With respect to wait times for specialist consultations, we caution that this is currently a manual process, there are no standardized reporting practices applicable to this data point and it may, therefore, be prone to underreporting.

You may request that this decision be reviewed by the Information and Privacy Commissioner of Ontario. Please note you have 30 days from receipt of this letter to request this review. The Commissioner can be reached at:

Should you decide to appeal this decision, please provide the Commissioner's office with:

- A copy of this decision letter
- A copy of your original access request; and
- The reason for your appeal.

Appeals to the Commissioner must be accompanied by the appropriate fee. If your access request is for you personally, the appeal fee is \$10.00. The appeal fee for all other access requests is \$25.00. Please include the fee with your letter of appeal. Appeal fees should be in the form of a cheque or money order, payable to the Minister of Finance.
