I am replying to your access request under the *Municipal Freedom of Information and Protection of Privacy Act*. You have requested any records from Payroll, Pension and Employee Benefits regarding the number of employees in 2024 who were eligible to receive multiple pensions upon retirement, including any data on total employer/employee contributions for second and third pension plans and the average number of full-time employees for the City of Toronto in 2024. Records search from January 1, 2024 - December 31, 2024.

Staff of Payroll, Pension and Employee Benefits have conducted a search for records responsive to your request. This decision reflects the results of that search.

## **Decision**

Access is granted in full to the following information provided by Payroll, Pension and Employee Benefits:

- No employees received or contributed to more than one pension plan payment.
- Average number of full-time employees in 2024 = 27,826.
