Re: Freedom of Information and Protection of Privacy (FOIP) Act Final Response to Request for Information

I am writing in response to your request for access to information under the *Freedom of Information and Protection of Privacy (FOIP) Act* to Acute Care Alberta (ACA).

Specifically, your request reads as follows:

Please provide data on the number of patients that died while on a waiting list for surgery or a procedure in fiscal year 2024-25. Please break the data out by procedure/surgery and case info – date the patient was referred to a specialist, decision date, date for the procedure and date of cancellation. Please also note the government's target time for providing the procedure in question. (Note: many hospitals/health regions were able to identify such cases as they track the reason for cancelled operations).

The timeframe for this request is April 1, 2024 to March 31, 2025. (Date Range for Record Search: From 04/01/2024 To 03/31/2025)

Please note that nothing in this correspondence constitutes a waiver of any privilege.

ACA regrets to inform you that they do not track deaths while a patient is on a waiting list and as there is no ability to correlate the patient's cause of death with the exam they may have been waiting for.

The challenge is attribution to the reason for death. Individuals do die on the wait list while waiting for things like cataract surgery, but they did not die due to that cause. Hence, the measure would only be appropriate if we were able to conduct a clinical review to determine what may have actually caused the death. This would be a tremendous and lengthy effort as nothing in place can meaningfully track this association.

Also note Alberta Health (AH) were the owners of Alberta Wait List Registry and Owner of the vital statistics data, they took the linkage approach. They have now indicated it is not available from AH either.

As per the FOIP Act, we sought to establish that an adequate search for records had occurred before responding to you.

We considered the scope of your access request and shared the wording you submitted to areas within the Public Body that would likely hold responsive records. We also asked whether there was there a more appropriate area to conduct a search or if records related to the



request also reside in another area of responsibility. Furthermore, we considered whether clarification is required should there not be enough details to perform a search for records.
